CORRIGENDUM PUBLIC NOTICE AUDIT OF THE TRUSTS

- (b) CA Firms having at least 3 years of experience in any scheduled commercial Bank.

(ii) **Nature of Contract:** 02 Years (subject to review after one year on the basis of performance)

(iv) The last date of submission of quotations have been revised from earlier 07.06.2024 (Friday) to 20.06.2024 (Thursday). Accordingly, quotations will be opened on 21.06.2024 (Friday) at 11.00 A.M.

L-1 will be decided on the basis professional fee quoted by the CA/ Firms for all the three entities together. Firms not quoting rates for Statutory Audit/ Annual Accounting for all the three entities will be summarily rejected.

(iv) In case of tie between the quotations of CA Firms, we propose the following criteria which shall be kept in view to decide the L1 for audit of the Trusts: -

- 2) Number of Years of existence of the Firm
- 3) Experience as Statutory Auditor with Est-JGB/ Est-VGB/Other Banks

- 5) Additional Qualification (CISA/DISA/Concurrent Audit etc.)
- 6) Registered office/ Head Office in Ranchi
